# Stolen Packages

**Cabbagetown Reynoldstown Security Patrol (CRSP) wanted to take this opportunity to address some of the recent instances of crime in our neighborhoods.** In particular, there has been a major uptick in reports of stolen packages from front porches.

CRSP is engaging with our officers to evaluate whether to add - or shift around - CRSP coverage in response. We thank the neighbors who have called 911 to report these activities. As a reminder, calls to 911 go directly to our officers when CRSP is on duty (as well as regular APD at all times).

We also wanted to make neighbors aware that for the past couple months, the CRSP vehicle experienced some costly repairs that caused CRSP officers to (generously) use their own vehicles (and to

continue to use bikes) for patrol. Still, it is our goal to use the CRSP vehicle as much as possible for visibility and deterrence. Thanks in part to generous contributions from individuals and new corporate members, the car has now been repaired, and

you can expect to see it more as we approach the spring and summer months.

# Cabbagetown Neighborhood Improvement Association: General Meeting

*Tuesday, April 11<sup>th</sup>, 2017, 7p at Cabbagetown Community Center, Meeting conducted by Katie Butler. Minutes recorded by Karyn Corell.*

## **1. City of Atlanta Liaison, Valencia Hudson**

Request for trash cans at Krog Tunnel and Dekalb & Wiley, fulfilled. Scheduled cleaning & pressure washing of Boulevard Tunnel this weekend and ongoing every six weeks. Natalyn Archibong donated 11k for our transportation committee study. Saturday free recycling event 11a-1p at 1110 Hill St. Nicole asked about turning water fountains in park back on. Valencia wasn't aware water was off. Will look into it. Krog Tunnel is about to get a facelift. Paved, cleaned, painted, lit, etc. Paul expression concern over recent problem with paint cans being left in Krog Tunnel. Dumpsters at end of Powell are gone. Thank you, Valencia. Katie asked about parks issues list. Valencia will look into it.

## **2. Atlanta Police Department, Zone 6**

Caught East Atlanta armed robbery assailants. Peyton (Public Safety) commented to police that a car was stolen on Tye and several cars broken into on Tye and Powell... rummaging etc. even though the repeat cars have been empty. Neighbor that has been a victim 5-6 times suspects that they are using electronic click devices to enter his vehicle, so will try to put keys in metal box at night to see if that helps. Police suggest continuing to keep cars clean. Dan asked about noise ordinance morning hours with leaf blowers...APD replied: 9a.

Special use permit for day care center: Denied: Conversion of old church on Seminole into Day care/preschool. Zoning review board approved it so Inman Park asks us to write a letter in support of Inman Park, especially given extended hours and 150 students/cars. Motion to write letter of support. Unanimous. Kwanza Hall in support of two new zoning ordinances: Micro Housing & Industrial Mixed Use.

**Peyton Public Safety:** Keep cars clean! You MUST report events to 911. Got \$5k in grant money from CSX for some lighting heading west on Wylie that the beltline is not covering. Asked about cutting shrubs on Wylie that are blocking half the sidewalk.

New Neighbor Welcome Party: 7p on April 21<sup>st</sup> at Gordon and Nas's house at 176 Powell St. We have about 25 new neighbors to welcome so please come out. This event is kid friendly. Annual **Cabbagetown Reunion will be held June 3<sup>rd</sup>**.

**Historic Preservation and Land Use, Nicole Seekely:** 670 Memorial (**Brother Moto**) Lin Ward representing **Paces Property**. Back side facing Powell, needs add a safety door for fire code. Repainting. Remove illegal, eyesore, wooden deck installed by previous owner, & Legitimize the window. We vote on the type 2. Motion, support, unanimous in favor, 2 abstentions. Commission voting tomorrow at 4p. Historic Preservation offers support. Nicole asked about parking regs and wants to make sure Powell St parking wasn't overused by Brother Moto. Mr. Ward says that other tenants are drop ship or non- publicly accessed offices that do not require additional parking. Neighbor expressed concern that once **Sock Fancy** opens the retail side, where are the parking spaces to come from? There are only nine total for Brother Moto and Sock Fancy that are already being filled by employees. Neighbor would like to see the site plan for the parking for the four businesses registered to that address. Lisa Myers expressed concern over board signs blocking/making it hard to see to pull out of Powell safely. Attorney said he would share the concern with Brother Moto. 107 Pearl St. Grandfathered triplex that had fire last year. Issue is the front. Duplex on bottom with third unit on top. Now making changes to modify the windows. Type 2 permit. UDC voted in favor for safety, over historic compliance. Sean made motion to support, unanimous in favor. 262 Iswald. Putting casement windows, replacing all the siding (requesting hardi-plank) Slight change to front porch roof, to make it standard shed roof rather than hip roof, restoring second front door, demolishing utility shed in back. HP in favor of all except siding. He is applying for financial hardship to be able to use hardi-plank. Smooth faced, not textured, of course! Motion to support by Dan, Seconded. Unanimous in favor.

## **Cabbagetown Initiative, Karin Kane**

Presenting budget for CI Main source of revenue **Chomp and Romp**. \$236k revenue. Presented budget copies to neighbors in attendance. Nothing unpredictable added from previous year budget. Net of \$36k when all is said and done. Keeping \$70k reserve in account in case Chomp & Romp don't net enough for expenses. Nicole moves to approve the budget. Approved unanimously. Elections for CI are coming up. Need President and Vice President. Need additional board member. Monthly meetings. CI basically runs the Chomp and takes care of the green spaces and parks in the n'hood. Tom, Karen, and Todd's terms are up. CI and CNIA merger task force. Get ahold of Katie Butler or show up at CI meeting to volunteer. Website CI & CNIA merger meeting happening tomorrow. Community Center overhaul committee moving forward. Had hoped for spring meeting, but **Perkins + Wills** are still working on drawings, so n'hood meeting will happen in late summer or fall.

**EPL Fund: Paul:** donation fund geared toward helping original families maintain their property. 2k max per recipient. Contact CI with needs noticed.

**Transportation Committee: Sean Houlihan:** Officially under contract with Urban Trans to do the transportation study for the n'hood. Meeting next Thursday, the 20<sup>th</sup> at 6:30p. Survey will be coming to neighbors in the next week or so. Workshop day in June to attend and talk to planner about concerns/questions. There will be beer and food. Concerns: parking, **Marta** expansion, traffic flow. Has support of Natalyn's office. Purpose is to tie several separate interests together, identify specific projects, costs, and implementation timelines.

**Imagine Memorial: Greg Giuffrida:** Pedestrian fatality (Barbara Crawford) recently in Kirkwood at 7:30p, but driver was found not at fault. High speeds, low visibility and lack of accessible crosswalk points were cited. No More Memorials on Memorial Drive celebration of life & safety rally for Barbara Crawford at **Peters Food Mart** 1895 Memorial Drive SE, Monday April 17<sup>th</sup>, 7-8p. Proposing several additional crosswalks on Memorial in highly trafficked areas. One in East Lake, Kirkwood near recent fatality, and at pedestrian gate at Cemetery at **Six Feet Under**. Proposing a pedestrian hyper-beacon on Memorial between Pearl and Boulevard that requires a full stop/red lights. Exact

location comes down to engineering but we are advocating for one in vicinity of Berean or Powell across Memorial. We are being asked to support the letter to **GDOT** for these crosswalks. Motion, seconded. Unanimous support.

## 6. Old Business

Lisa Myers is nominated for one – introduced herself and proclaimed her focus to be to promote one-off days of commitment or service and small ways to get involved in projects in the neighborhood. # Traffic Calming Measures for Memorial

Atlanta City Councilmember Natalyn Archibong introduced legislation requesting the Georgia Department of Transportation (GDOT) implement traffic calming measures along the portions of Memorial Drive within the Atlanta city limits.

Councilmember Archibong said she would like to see Memorial Drive become a safer corridor for walkers and cyclists, with inclusion of green spaces at a time when new housing and amenities, including restaurants and businesses, are rediscovering what many refer to as the "gateway to Atlanta."

*"The Memorial Drive Corridor, especially the portions that lie within the city limits, is experiencing a rebirth. The future of Memorial Drive depends on what we do today to address traffic along the corridor,"* Archibong said. *"Issues such as speeding, visibility for motorists and*

*pedestrians and the lack of adequate pedestrian crosswalks have become a public safety concern that needs to be addressed with short-term and long-term solutions."*

Memorial Drive (State Route 154) connects downtown Atlanta to DeKalb County, and ends at Stone Mountain. Memorial Drive is a state road which falls under the purview of the Georgia Department of Transportation.

Councilmember Archibong and members of the advocacy group Stakeholders of the Memorial Drive Communities have drafted a letter this month to GDOT Commissioner Russell R. McMurry and state officials detailing the serious safety concerns shared by citizens in the communities along Memorial Drive.

**The Cabbagetown Historic Preservation and Land Use Committee** exists as a resource for all property owners, builders, developers, real estate professionals and others interested in renovation and redevelopment in the neighborhood. We take an active role in reviewing all development proposals (big and small) for Cabbagetown. This monthly "corner" will be here to answer FAQs and common misconceptions about working in the neighborhood.

When Cabbagetown was established as a landmark district on June 19, 1989, the Urban Design Commission identified all the existing buildings at the time that "contributed" to the character of the neighborhood. These buildings, even today, set the benchmark for renovations, restorations, and new development work done in the neighborhood. Check out the map on page 13 to see which properties are considered contributing versus non-contributing.

Most of Cabbagetown is guided by the compatibility rule. This means any new construction or renovation must be compared to only the contributing buildings on the same block face (your side of the street between the two closest intersections). The compatibility rule guarantees that alterations to existing structures and new construction are compatible with the design, proportions, scale, massing, and general character of the contributing buildings in the immediately adjacent environment. This is how we're able to let Cabbagetown evolve while still keeping the same characteristics that made it a landmark district in 1989.

# Getting Ahead of Canopy Loss

**Many Atlantans are alarmed by the rapid loss of trees in town these days.** Buzzwords like 'good urbanism,' 'high density,' and 'sustainability' pepper many conversations about new development in Atlanta, but our urban forest – and our corresponding civic identity as the 'City in the Forest' – suffers from rampant tree loss. This current reality begs the old adage: Are we literally missing the forest for the trees?

**The question is simple:** How is Atlanta going to grow *WITH* its trees? We have the chance to write that narrative now, while we have remnant greenspace to work with. Solutions must be sought through more innovative design and holistic development. **Trees Atlanta** will continue planting trees everywhere we can, but we simply cannot keep pace without working together to actively protect our existing forest, too. We simply must do both.

Attending NPU (neighborhood planning unit) and civic association meetings can be a good place to start to learn about new projects coming up in your part of town. At this level of planning, developers often present conceptual plans to the neighborhood, especially when seeking a zoning change or variance; this can be an effective stage for citizens to get involved and speak for the trees. But let's also consider some bold ideas to get ahead of this canopy loss pattern.

One possibility would be tree conservation overlay districts. This may sound familiar if you have attended any of the Atlanta City Design public presentations by Ryan Gravel. A major pattern emerging from that visioning process is the stark distinction between our leafy-green in-town neighborhoods, versus the major thoroughfares, where density, new development and transit options make sense.

What if the cost of tree removal more accurately reflected the services it provides for our communities and savings on public infrastructure? Currently, the cost of removing a healthy tree in the City of Atlanta is \$100 per tree, plus \$30 per inch diameter at breast height (DBH), or replanting inch for inch (which is often not possible). For builders, this is simply the cost of doing business. What sorts of incentives might we place on tree preservation instead of imposing

minor fees and penalties for their destruction? Let's acknowledge the public health benefits provided by healthy trees and soils, and assign more appropriate values accordingly.

Maybe there are some cases where a tree simply should not be removed – period. Other southern cities provide restrictions on certain, significant trees: Charleston recognizes "Grand Trees and colonnades;" and Nashville designates "historic and specimen trees." Nashville also draws an interesting comparison to Atlanta: of its 247 square miles, they average 47% urban tree canopy, a close running to Atlanta's 48% average canopy across 133 square miles. As both southeastern cities grow rapidly, which will remain a true City in the Forest?

**When does it make sense to build taller buildings (rather than low and wide) to save greenspace?** When discussing design alternatives with developers in your neighborhood, look out for opportunities to achieve density vertically rather than horizontally if it affords for existing trees and quality greenspace to be incorporated into the plans.

**What if we restricted the sale and planting of English ivy, or Chinese wisteria?** The evidence is all around us; these vines are slowly suffocating our trees.

**What if the City had more dedicated funding to purchase and protect large, forested parcels of land?** Imagine a network of publicly accessible, protected community forests, cherished by all Atlantans.

Development and conservation need not be mutually exclusive, and in fact, we cannot afford to take that polarizing approach any longer. Until our policies can be updated, let's collaborate across stakeholder levels to maintain 48% tree canopy coverage in the City in the Forest. We don't necessarily have to reinvent the wheel, since we can look to other cities for guidance. What changes would you like to see in the Atlanta Tree Protection Ordinance? Which developers can we look to who are actively trying to do this better – even if they don't have to? Let us know. *A regular meeting of the Board of Directors of Cabbagetown Initiative CDC was called to order at 7:05 PM on April 10, 2017 at Cabbagetown Community Center by President Karin Kane.*

## **I. Approval of Agenda**

The agenda for the meeting was distributed and unanimously approved.

## **II. Review of Previous Minutes**

The minutes of the March 13<sup>th</sup>, 2017, meeting were distributed and unanimously approved. The board had discussion about recording the meeting. Todd asked if he had permission to record. An opinion was expressed about not disseminating recordings. There was also discussion about making sure to review minutes carefully. Board members should weigh in when questions are raised. Todd withdrew his request, and the meeting was not recorded.

## **III. Treasurer's Report**

There was no financial update. Paul will follow up on W9s for the EPL funds expenditure.

## **IV. Reports**

### **a. Governance Committee**

The CI/CNIA Merger Task Force is moving forward. Chris has reached out to Terri Theisen to engage her in these efforts.

For the board seat vacated by Katie Butler by her election as CNIA president, CI must elect a new director. A statement of interest from Morgan Felts was presented to the board. The vacated seat will be filled for a new two-year term, per the bylaws.

MOTION: To elect Morgan Felts to a two-year term as a director effective May 2017 (APPROVED unanimously).

Todd Kane announced that he will resign by the June meeting. Tom Deardorff will resign effective at the May meeting. Todd will contact the Editor about placing an notice for new board members in the newspaper.

### **b. Chomp & Stomp Committee**

Sponsorship materials are not yet available; we will have them by next month. The Chomp committee engaged someone to handle contracts last year and she is under consideration to also handle logistics this year. The board needs to know how much it costs in order to exercise oversight of large contracts. As long as the Chomp coordinators are coming to the board for approval, the board does not need a motion. There was a decision a few years ago that items over a certain dollar amount were to be approved by the board. Katie will confirm with Chris what that amount is over which board approval is required.

Board members should attend Chomp meetings and anticipate playing an oversight role. Karin will ask for a full report from Whitney for the May meeting. We now have a registered trademark for Chomp and Stomp. There are requirements that we take steps to maintain the trademark. The board needs to make sure we can follow these requirements despite our term limits. Our registered agent should maintain these records and pass them along if that person is ever not our registered agent.

### **c. CNIA**

Website is being updated; the kick-off meeting will be held Wednesday, 4/12. CSX provided a \$5K grant to CI for the wall and let CI know that they may have additional funds available in June. Karin is maintaining a connection with CSX to keep up with this.

### **d. Parks Committee**

For necessary park repairs, 15 companies were recommended by Trees Atlanta. The committee is working on getting three comparable bids. They are asking for tree work, but the companies want to bid on making an assessment before doing work. Todd had another company to suggest and will email it to Tova. Board members asked how long does it should expect to wait for the city to respond to requests. Karin responded that the city says they will respond within 45 days. We can follow up with our councilmember. The committee also shared that it's exploring an "adopt a planting bed" program.

### **e. EPL Fund**

At the March meeting, another neighbor in need of help was mentioned. The committee reported that it will not need to use funds for that home. Another home was suggested by Karin. The name of a volunteer was recommended to Paul by Katie.

### **f. Community Center**

We are waiting on information from Perkins+Will. The committee is establishing next steps and anticipates hosting an event to show the results to neighbors later in the summer.

### **V. New Business**

The board encourages its members to link their AmazonSmile accounts to CI. A board member suggested putting a banner at top of a page in the Cabbagetown Neighbor to remind neighbors about this option.

At the previous meeting, someone offered funds to assist with Cabbagetown Reunion. The board did not make a decision. Karin said reunion would be held on Reunion Day without a second event this year. Katie said that CNIA will handle the Reunion, as in previous years.

There is an issue with trash along the Krog Tunnel. Karin requested a regular cleaning from the city for the tunnel. She will put it on a six-week rotation. We could also reinstitute regular cleanups. In the future, we should pressure the Beltline to maintain both sides.

*Here in Cabbagetown, we are fortunate enough to live in one of the few neighborhoods in Atlanta that has preserved much of its history.* It's easy to take that history for granted and forget how special this place is. I'm guilty of it; biking (to say nothing about driving) to work through the neighborhood, it's easy to miss the quirk and the grit that makes our community so unique. Yet, it's just this quirk and grit that I believe is the essence of Cabbagetown.

I'm going on 17 years in Mill Building No.1 (H), and I can think back on many of the quirks that make me proud to live in this neighborhood. One of my favorites was the little 'dog window' cut out of plywood and painted like a jester outside John Dirga's place on Carroll St., so that when the dogs poked their heads through to bark at passersby, any menacing tone their barks might have elicited were instantly disarmed by the jester painting around them. I miss that experience.

*There is pressure on all sides of our little slice of eclectic heaven, and it feels like we need to remember our roots now more than ever.* Here in the mill, we walk a fine line between interesting and quirky lifestyles and a slightly more refined way of life that comes along with home prices that approach \$500k. Yet, I find myself asking the question: Why have home prices risen so high around here despite the rough edges that could be easily avoided by living in other parts of the city?

*Perhaps it's precisely because of those rough edges that desirability has continued to climb around here.* In fact, you would be hard pressed to find any place in the region that has this kind of 'x-factor'. It becomes obvious when bringing a visitor onto the property for the first time and watching as they try to take it all in, or walking an out-of-towner around the neighborhood while they remark how cool the murals are on Wylie, or how neat all the businesses are on Carroll Street.

In some ways I find myself puzzled by those who don't celebrate the grit and quirk of our home. We all chose to live here when we could have chosen elsewhere. The things that make our community unique cannot be easily replaced if they were to be lost.

I find myself thinking of this often as I look around at the aging structures of the mill. The very things that give this place its edge are threatened by time and the elements. I can only hope that when it's time to decide what's worth saving, we remember how lucky we are that so much was saved before we arrived. *We are the custodians of a rich history and what people see and experience in ten years is up to us, now.*

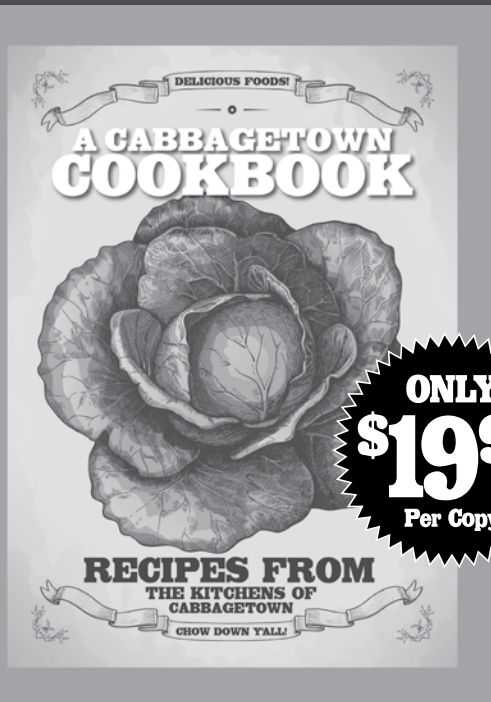

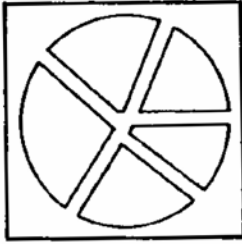

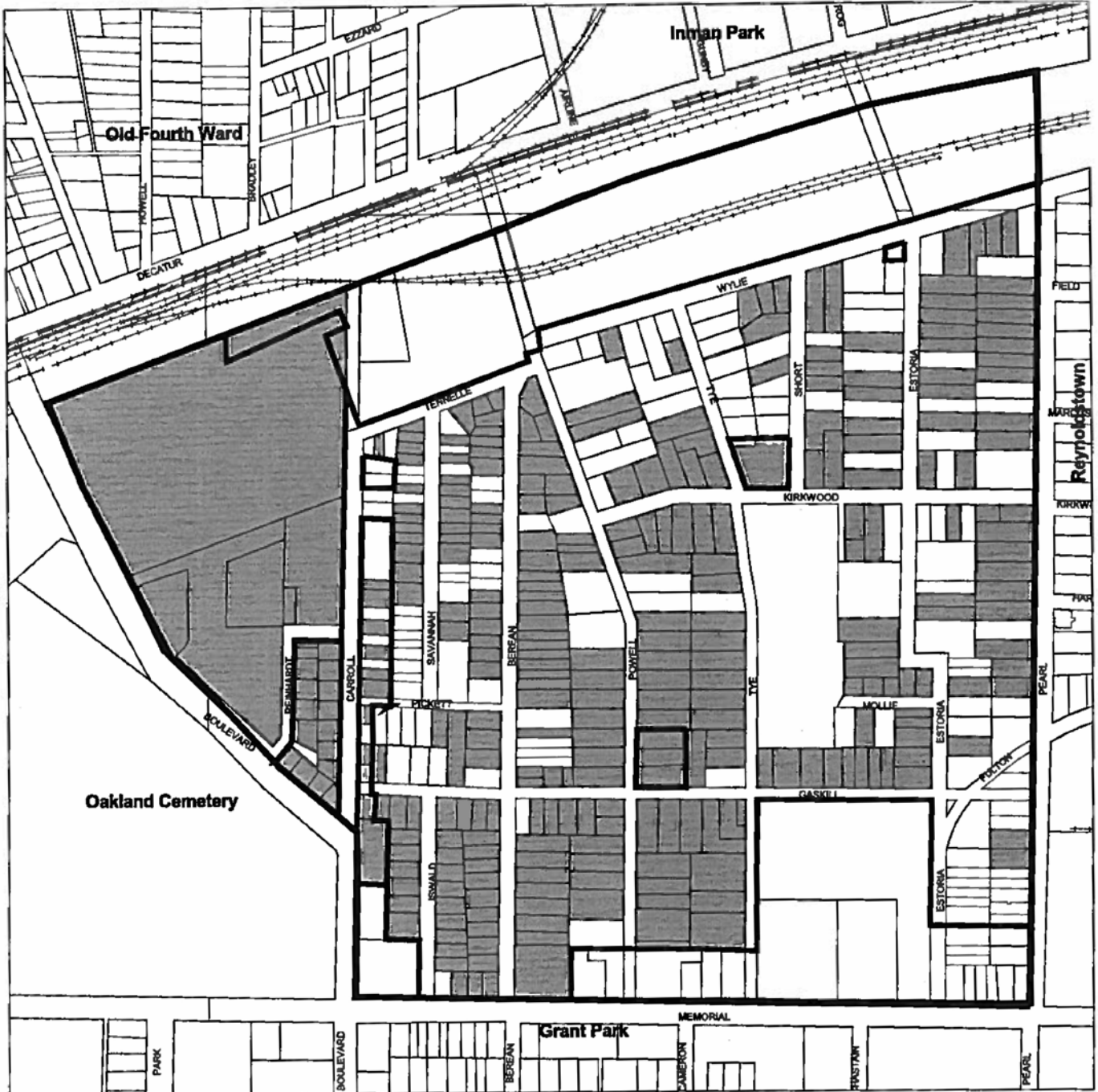

# Get Your Motor Running...

Cabbageheads rejoice! Georgia DOT officials state that the I-85 bridge will reopen by Memorial Day! "Our goal was to get I-85 back open to the people of Georgia as quickly as we could, and to do so we



offered incentives for early completion," said Georgia DOT Commissioner Russell McMurry, during the DOT's weekly press briefing on bridge repairs.

"If work is able to continue at the rate it's been going, I have no doubt project contractor C.W. Matthews will be able to meet, if not beat, the May 25<sup>th</sup>

incentive date," McMurry said. Northbound Cabbageheads have also noted some road resurfacing.

"The 24/7 ability to work has accelerated this progress," he said. Crews recently installed the last of the support beams for the new bridge.
